In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 200 tCO₂e by 2030.

This is a reduction of approximately 6% per year

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or baseline. The carbon emission reduction achieved by these implemented since the 2022 schemes equate to 5 tCO₂e, a 19%ge reduction against the 2022 baseline and the measures will be in effect when performing the contract.

We have completed installation of LED lighting and in March 2024, completed installation of solar panel across all of our manufacturing sites. In the future we hope to implement further measures such as: Further solar panel roll out
